The BROOME COUNTY LAND BANK CORPORATION (BCLBC) is seeking applications from qualified persons from the County of Broome for the following position:

#### **Member, Community Advisory Panel**

The mission of the Community Advisory Panel (CAP) of the BCLBC is to advocate for the purpose and programs of the BCLBC to the community and to inform the BCLBC of the impact of its programs and policies in the community. The CAP serves solely in an advisory role to the BCLBC.

#### **TERM OF APPOINTMENT:**

Term of appointment for CAP members is a 2-year term with an opportunity for renewal with Board approval.

#### **RESPONSIBILITIES/DUTIES OF CAP MEMBERS:**

- Advise BCLBC staff on activities in their respective communities or organizations;
- Distribute information about the BCLBC mission and activities within their communities;
- Advocate positively about the programs and activities of the BCLBC;
- Provide recommendations for activities, programs or policies relevant to the BCLBC mission
- Communicate about issues or concerns related to BCLBC policies and programs

The CAP is a 9-member committee appointed by the BCLBC Board of Directors, who is committed to assuring that its appointments are representative of the County's diverse community. The CAP will be composed of the following positions:

- Four (4) Local Government Representatives
- Two (2) Community Development Organization Representatives
- One (1) Real Estate Representative
- One (1) Business Representative
- One (1) Neighborhood Association Representative

CAP members must reside in Broome County.

The CAP will meet once a quarter.
