RESOLUTION AUTHORIZING THE EXECUTIVE DIRECTOR TO ENTER INTO AN AGREEMENT WITH THE VILLAGE OF DEPOSIT FOR THE DEMOLITION OF 125 FRONT STREET, DEPOSIT, NEW YORK 13754 TO BE USED FOR FUTURE COMMUNITY DEVELOPMENT, AND BE IT

FURTHER THAT, THE LAND BANK QUALIFIES FOR CERTAIN TIPPING FEE CREDITS EACH CALENDAR YEAR PURSUANT TO BROOME COUNTY CHARTER §317-9, AND BE IT

FURTHER THAT, THE LAND BANK WILL ALLOCATE CREDITS IN AN AMOUNT NOT TO EXCEED \$17,000 TOWARD THE DEMOLITION DEBRIS OF 125 FRONT STREET, AND BE IT

FURTHER THAT, THE EXECUTIVE DIRECTOR OF THE LAND BANK IS AUTHORIZED TO EXECUTE AND DELIVER ANY AND ALL DOCUMENTS WITH RESPECT THERETO.
